- Membership in Unit 249 stands at 1130. There have been 4 renewals, 2 deaths, 3 not signed up due to health reasons and 4 not interested for various other reasons.

**Tournament Coordinator Report:** Chris Punter

- Looking at the prospects of holding a tournament further south from Owen Sound, possibly around Goderich; Chris to investigate further.

**Tournament Reports:** Richard Fokes

- Port Franks reports a total income of \$5,733 with expenses of approximately \$5,535 for a profit of \$197. Jean has indicated that she plans to increase table fees for next year's tournament to increase profit; Richard will convey the board's recommendation that table fees remain stable; any profit is acceptable so no change is necessary.

- Kitchener Waterloo Summerfest reports a total income of \$8,206 with expenses of approximately \$7,558 for a profit of \$648.

- Sarnia tournament reports a loss of \$770. Tournament chair, Charles Dalmas is very enthusiastic but Sarnia tournament has reported losses for numerous years; it is felt that Sarnia players are not interested in participating in a tournament. We'll fully support the tournament for 2012, but will advise that if improvement is not seen the Unit will need to reconsider the appropriateness of continuing with a Sarnia tournament in 2013.

Moved by Tom Ramsay and seconded by Richard Fokes that honorariums be sent out to Jean Potthoff and Ted Boyd for their tournament chair work.

**Approval of Committee Reports:** Moved by Lee Easterbrook and seconded by Tom Ramsay that all committee reports be accepted - CARRIED.

**New Business:** It has been suggested that the Unit petition ACBL to increase the ceiling for masterpoints earned through internet tournament play that can be included in total accounting of member masterpoints for competing in various ACBL races (Mini McKenny and Ace of Clubs). Unit 249 Board of Directors feels that accumulation of masterpoints through internet play interferes with

club participation; we do not support including internet masterpoints in ACBL race calculations.

- One nomination for new board member, Jed Drew, and one request from Mavis Reffell, to be re-appointed to the board; George Hodgson and Mavis Reffell will be reappointed.
- Decisions need to be made about whether to hold Unit finals for NAP games, to qualify pairs for the District final. Lee to contact club managers to ask if they have held a NAP qualifying game in June, July or August, 2011 and if so, are any of those pairs who qualified, interested in attending the District final in Toronto, (or participating in a Unit final?)

**Nominating Committee Report: Bob Burns**

- Notice of Meeting and Nomination forms were distributed by email to Club Managers and Owners on June 2<sup>nd</sup>. John Carruthers, editor of the Kibitzer and John Lightfoot, website administrator were also notified on June 2<sup>nd</sup>, for inclusion in the fall issue of the Kibitzer and for posting to the website.
- Two proposals to govern the election that is provided for by the Constitution.
  - o That the election today just be for seats on Unit 249's Board of Directors to serve for a two year term, 2012-2013 and that the newly elected Board appoint within its body their Executive Officers: President, Vice-President, Treasurer, and Executive Secretary.
  - o That the term of office for the current President, Jim Brimner, be extended till the newly elected Board of Directors appoint its Executive officers.
- Nine nominations have been received in accordance with the guidelines laid down by the Constitution. The Board may consist of 10 elected members and by appointment 4 more. A geographical area as outlined in the Constitution may have up to 4 elected members but no more than 5 with the addition of appointed members. The Board has historically given preference that each geographical area has at least 1 member.

The following are the Nominees by geographical area:

1. Windsor, Chatham, Kingsville and Ridgetown: Lee Easterbrook and David Boley.
2. London: Richard Fokes and Chris Punter

5. Goderich, Kincardine and Owen Sound: John Lightfoot.
6. Sarnia: I would like to commend Pat Simpson for his efforts in trying to secure a member from that area. Notably, he approached: Blake & Martha Maxfield, Avinish Saxena, Jerry Vopika, Charles Dalmas and Mark Pettit. George Hodgson and Mavis Reffell will be re-appointed, representing the Sarnia area.

This proposed slate for Unit 249's Board of Directors is within the guidelines as laid down by the Constitution and therefore no election is necessary. Moved by Bob Burns and seconded by Tom Ramsay that the nominees be elected by acclamation.

“Ha! Ha! Ha! That’s good, but I really need to know because we need about 900 of them on each of two nights. Really. We don’t need the waiters, or the tables or tablecloths, no water service, no fries or drinks or silverware; just the dogs.”

But \$14.50 was the real asking price for a hot dog at the Sheraton Centre! So we negotiated for a few months and they came all the way down to \$10.50. The asking price for coffee was \$5.00/cup, and don’t even guess about the Pad Thai!

After we met in June with the ACBL folks, they took up the cause with the hotel and mentioned to the hotel people the total value of the deal, including room rentals (quite a few dollars). After

that, the price of a hot dog came down to just over six bucks!

There were some glitches in the four-year process of putting together the NABC but the results were terrific. The overwhelming response was positive. Most players had a great time and enjoyed the city. They loved the spirit of the volunteers. The hats and balloons set the stage. Players told us how much they enjoyed Canada and Canadians. You made them feel welcome. When one of you commented to an American how surprised you were that they would come to Canada to spend their money, given the exchange rate, the American said, “I might as well spend it while it’s still worth something!”

Yes, there were some complaints. The most frequent of these was the dissatisfaction with two different hotels and different playing sites. (The ACBL looks for a hotel that has enough rooms and playing space but that’s not available here at a price that’s acceptable.) There were those unhappy with the prices in Toronto, but that’s the case with any world-class city. Someone told me that he didn’t like the registration umbrella, and then it rained and he liked it! Oh well.

We ran out of the beaver “stickies” (we had 5000) and the umbrellas and the bags. We were told to expect 13,000 tables but finished with 13,914, which was huge considering the economy on both sides of the USA/Canadian border and that our American friends needed passports this time.

The Intermediate/Newcomer games were very popular and this is encouraging for the future of bridge. So, too, were the Youth NABC events.

CONGRATULATIONS and THANKS to all the volunteers who helped make this tournament a success. Special thanks to the members of the Planning Team (Brigitte Blackhouse, Flo Belford, David Cohen, Ina Demme, Louise McNeely, Bruce Reid) who spent so many months preparing for 12 days of frenetic chaos!

## ERIC KOKISH FETED AT ACBL HALL OF FAME DINNER

On Thursday July 21, the ACBL Hall of Fame added Eric Kokish. Kokish is known nowadays mainly for his success as a coach – most notably of the Nick Nickell team – but he has also excelled as a player, bidding theorist and writer.

Sami Kehela, another Canadian who is a member of the ACBL

Bridge Hall of Fame, told the crowd at the dinner that he feels largely responsible for Kokish's choice of careers.

"Not long after Kokish earned a law degree," Kehela related, "he asked for advice about possibly starting a career in bridge." Kehela strongly advised against such a move – and Kokish went right out and did it anyway.

Kehela recalled that in 1980, as the Canadian team was preparing to head for the world championships in Valkenburg, Netherlands, he told Kokish not to offer unsolicited advice to Eric Murray, one of Canada's all-time great players, also now a member of the ACBL Hall of Fame. Kokish was a member of the team.

"For one thing," Kehela said, "Murray has been playing since before you were born, and for another, telling him how to play could be hazardous to your health."

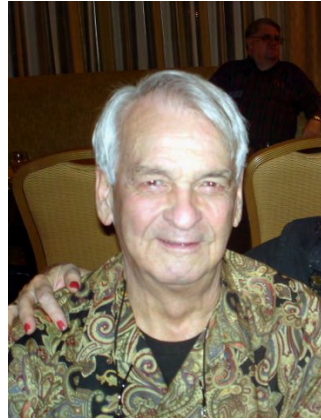
"Sure enough," said Kehela, "Murray was involved in an auction involving a takeout double (by him) that didn't work out for the best. In the post-game discussion, Kokish had to ask Murray, 'Are overcalls part of your repertoire?'"

"I just barely kept Kokish from bodily harm," Kehela remarked.

# Canadian Bridge Federation Inducts Five New Members in Toronto Ceremony

In a ceremony at the Royal York Hotel during the Summer North American Bridge Championships, five persons were inducted into the Canadian Bridge Hall of Fame. They are:

**Ralph Cohen.** One of the top players in Canada during the 1960's, Cohen played with Sam Gold in the first Olympiad Teams, coming fourth. Cohen later became the top administrator in the ACBL. He held executive positions in the WBF for many years

**Diana Gordon.** Canada's most decorated female player, with gold, silver and bronze medals from world play. Gordon has won more CWTCs than any other player and competed in seven straight Olympiads. She will play international competition in the sixth decade in this year's Venice Cup.

**Doug Drew.** The chief architect of the CBF and designer of the two all-Canadian districts in the ACBL. Drew was the first Canadian president of the ACBL and instigated formation of its Educational Foundation. Drew held elected office from the Fifties to the Nineties.

# DREAMS

By Malcolm Ewashkiw

At the end of the 1941 film *The Maltese Falcon*, Sam Spade accurately appraises the significance of the rare bird that so many people risked their lives to hunt down. Bridge players don't have to hazard so much in their pursuit of rare treasures. But they can still track those rare and beautiful treasures and stand in awe when they encounter one.

Squeezes are often considered the rare creatures of the bridge world and one of the rarest is the trump squeeze. Through the power of BBO, I witnessed two declarers in different parts of the world execute these beautiful plays within hours of each other.

The first extraordinary creature emerged in Asuncion, Paraguay during the South American Team Championship semi-final match between Argentina and Chile.

At the time this deal arose, Argentina held a slim 112-101 lead. On board 55, the Argentine East-West pair had settled in three no trump, making six. Chile's Marcelo Caracci and Jose Manuel Robles were more ambitious.

At the other table, the Argentine West had chosen to open three diamonds, so his partner quickly subsided in three no trump. When Caracci chose to open one diamond, Robles was suitably enough encouraged by both the opening bid and the location of the king of hearts to undertake a slam.

Carlos Pellegrini led the ace of hearts and continued with a heart at trick two. Declarer has 11 top tricks and at first blush the contract appears to depend on the club finesse; however, Maestro Caracci looked deeper and found an elegant position, perhaps influenced by North's weak jump overcall or perhaps merely influenced by the artistry of the moment.

At trick seven, after four rounds of diamonds, Caracci arrived at the classic trump squeeze end position (see top of next page):

When Caracci led the eight of diamonds, North discarded the ten

of hearts, East the six of clubs, and South...?

South had no winning discard, but chose the seven of clubs. Reading the position perfectly, Caracci played the ace, king of clubs and claimed 12 tricks when the queen appeared.

This 12-IMP swing powered Chile into the lead. They increased their margin to win 194-170. Reaching the finals meant they would be one of two countries to represent South America in the World Bridge Championships in Veldhoven.

And what if Caracci had not taken this moment to flirt with one of the rarities of the bridge world? Going down would have added 13 IMPs to Argentina's total, a swing of 25 IMPs. Chile would have lost by 1 scant IMP. Ah, the stuff that dreams are made of.

Having just been mesmerized by Caracci's dummy play, next morning I tuned in to the European Open Championships being played in Poznan, Poland. The second set of round robin matches from the Mixed

Teams championships had just begun and, noting that Team Lavazza was playing one of the matches, I logged on to the table where Giorgio Duboin was playing with Maria Teresa Lavazza. I arrived just in time.

After Duboin's four-club call, the BBO commentators speculated on why Lavazza's next bid was taking so long. Four diamonds and four spades were offered as possible bids for her to make. When the actual four-heart bid appeared, one commentator suggested that four clubs might have been a "key-card ask or something"

In fact, that was exactly what Duboin's bid had been. Lavazza, eventually recognizing she had given the incorrect response, raised to six,

presumably holding one more key card than she had promised. It remained for Duboin to create a positive start for Team Lavazza.

North led the jack of diamonds. South won the ace and switched to the four of hearts. At this point, one commentator noted that “on the surface declarer has quite a bit to do – Vienna Coup is being suggested but other lines might fail.”

As Duboin led a spade to dummy’s ace, the same commentator observed that, “North could certainly be embarrassed in the majors.” And as Duboin ruffed a diamond to hand, another commentator suggested that declarer would “try to bring down a short queen of spades first.”

That comment hung in the air as Duboin seized the moment, reached into the treasure box, and enthralled us all with his magical skill.

After ruffing the diamond, Duboin crossed to the ten of clubs, ruffed a second diamond, overtook his king of clubs with dummy’s ace, and cashed the jack of clubs discarding a heart. For the second time in less than 24 hours, the classic trump-squeeze matrix appeared before me (See *top of next column*):

Declarer cashed dummy’s king of diamonds. South discarded the four of diamonds, declarer the nine of hearts, and North...? The defender in Poznan was as helpless as his counterpart in Asuncion had been. He chose the six of spades.

Just as Caracci had done hours earlier, Duboin read the position perfectly. He led a spade to the king, ruffed a spade bringing down the queen, and crossed to the heart king to cash the established jack of spades. The commentators were ecstatic: “Excellent card reading; bridge of the highest standard; great play!”

Why did Duboin choose to play the hand this way and not try to ruff out the spade queen or take a spade finesse? I like to think that, like that great magician Prospero, he wanted once more to weave his magic spell around us all – the stuff that dreams are made of.

# THINKING BRIDGE

**Opening lead:** ♠

**Bidding commentary:** There are many ways to bid the East hand, but it's not unreasonable to leap to slam facing a two-level overcall. Most two-level overcalls show opening-bid values and a six-card suit. This is about as light as they come – just East's luck.

**Play commentary:** West adds his 11 HCP to dummy's 17 HCP, a good habit to form, and comes up with 28, meaning North-South have 12 HCP.

Normally an opening bidder will have 12, but given the opening lead, South figures to have only 11. In other words, South has the king of clubs and the queen of diamonds. Finesses in those suits are doomed to failure – West must think of something else. An elimination play to force the opening bidder to do something positive for declarer is the answer.

**Further play commentary:** Using the bidding as a guide, West crosses to his hand twice in hearts to ruff spades, stripping that suit from his hand, and continues with the king of diamonds, goes over to the ace of diamonds and then plays the diamond jack, disdaining the finesse that cannot work.

When South produces the expected diamond queen, West discards a club. South has the lead and is not a happy camper. A club return is out as it would go into the ace-queen. A spade for a ruff-sluff is not any better. However, assuming a spade return, West discards yet another club and ruffs in dummy. West remains with one club and dummy has the ace. Contract made.

**Tip:** Use the bidding to guide you in the play. Assume an opening bidder has at least 11 HCP, and stay away from finesses that can't work.

**Further tip:** Don't write or telephone me to tell me that a club lead beats the slam. I knew that even before my partner, South, pointed it out..

## CRUELTY

This summer, I went to the Kalamazoo Regional in Michigan. It was a pleasant few days in an auditorium on the outskirts of town. Refreshments were free and the opponents were always pleasant and capable of good play. It was interesting that you were compelled to play three sessions a day in each of the three major knockouts. Tournament schedules continue to be flexible as the population changes. In Florida in February, for example, the Sarasota Regional has only morning and afternoon games, and a short lunch break at that.

At the table, I am still shaking my head at a hand that Mike Cafferata and I encountered with six hands to go in a Knockout final. I felt at the time that we had a healthy lead - we did - but this hand changed everything.

The opening lead was a heart and when dummy came down I was very pleased that we had bid this tricky hand to the best spot. I had nine tricks for sure and just needed another diamond or club trick to make my contract. My Right Hand Opponent cashed the heart king and ace and, seeing dummy's diamonds looming, shifted to the club eight.

As you think about the hand, you realize that he was forced to lead a club to have a chance to beat the hand and might have anything, even king-eight doubleton. I played the ten and LHO played the jack. I could have ducked this if I thought the eight was from eight-three doubleton, but I didn't think so.

I won the ace of clubs and drew trumps in three rounds, then tried the diamonds. When they didn't split, I led a club toward my hand. RHO showed out. Yuck. The layout was cruel. The hearts had finished on my right, which was necessary for them, and the club layout was unconquerable. Minus 50. Win the bidding contest and lose the war.

What happened at the other table? Our counterparts got to the terrible contract of three no trumps from North and got a low heart lead from the ace-king-ten-six-two. Having no

outside entry, East wanted to maintain transportation options. The queen won in dummy and declarer ran for home with ten tricks and

plus 430. Lose 10 IMPs. The worm that turns had made its appearance. We lost the match.

## OVER THEIR SHOULDER

**By John Cunningham**

Follow along with me on these two deals and see if you come to the same conclusions I did.

Good players fancy they are adept at visualizing the other three hands, even in the bidding. Witness this South hand, vulnerable, at match-points; you hold:

♠ 9 7 5  
♥ Q 10 8 3 2  
♦ 8 7 6 4  
♣ 8

Partner doubles West's strong no trump and East passes to you. Before you choose between passing and bidding hearts, you need to know that partner's double shows a four-card major and a longer minor. Can

you make anything of RHO's unalerted pass? Is it wise to ask? What to bid? Pass seems farfetched. Two clubs would be the de facto minor-suit request and two diamonds the major ask.

Two of a major could be to play, as an unpassed hand, or, as I prefer to play it, pass or correct. Partner is humouring me, sort of, by playing this, but is unfamiliar with it, and in general.

I expect that partner has spades and clubs. Maybe even six clubs, and sometimes these 5-1 fits play reasonably well. Sooooo, I bid two clubs, rather than the 'automatic' two diamonds. We weren't doubled yet. With good reason. It turns out to be our hand - in hearts, though, not clubs.

The opponents are polite about it, and I decide to forego explanation. As I said, some of us are just good at

visualization. Some of us. The full hand:

♠ A K Q ♥ A J 9 6 ♦ 9 ♣ Q J 6 5 2 ♠ 10 6 3 2 ♥ K 5 4 ♦ A K Q 10 ♣ A 9 ♠ 9 7 5 ♥ Q 10 8 3 2 ♦ 8 7 6 4 ♣ 8	♠ J 8 4 ♥ 7 ♦ J 5 3 2 ♣ K 10 7 4 3

That the opponents dropped a trick in defence and beat me one was little consolation for the 1½ matchpoints we received for my astute 'visualization'. We beat one pair who allowed East-West to declare one no trump and managed to let them make an overtrick (minus 120) and we tied another pair with visualization skills equal to mine who declared two spades from the North hand down one (also minus 100).

On the following deal, I decided to see if East's visualization abilities were as extraordinary as mine. They were. I was kibitzing at Hazel's Bridge Club. My kibitzee held, with both sides vulnerable:

♠ 10 9 8 6 2  
 ♥ 10 6 5  
 ♦ Q 7 6  
 ♣ J 4

Sometimes, in all those hours of kibitzing, something really interesting (read bizarre) comes up. Witness.

East appropriately passed when his partner's one-diamond opening bid was overcalled by North with one spade. So far, so good. When South passed one spade, West reopened with two hearts, which provoked a three-club bid from RHO. Had I the East hand, I would reflexively raise diamonds now; this must be a useful hand for partner, and I am not bright enough to fear five clubs by them.

But no. My kibitzee passed. South passed (more on this later). West, evidently still enamoured of his hand, doubled. North passed and East pulled to three diamonds, then South bid? Well, three spades. Don't ask me why (as I said, more on this later).

It's not over. My kibitzee doubled this in the passout seat, in Pavlovian fashion. And everyone passed. Time to look at the full deal:

North misplayed it, perhaps, for two down into their stone-cold five clubs (yes, six can be made). It seems I am not the only one who needs his prescription refilled. Not one pair played in clubs. (Possibly the diamond people were up against clubs,

though.) The North-South scores ranged from minus 1100 for three no trump doubled down four by North to plus 500 for five diamonds doubled by West down two.

I sort of liked North's three-club bid, and it happens that East's pass over that bid turned out potentially well. But after that?

What about that South hand? Large in support of clubs, isn't it? I think it is too good for four clubs over partner's three clubs; I would bid three diamonds here, though five clubs has my sympathy, and four diamonds might get a nod. It depends on partner's proclivities. Anyway, South PASSED three clubs. He did indeed have a preference for clubs. But then over three diamonds, he soldiered on with three spades, and stood the double! His visualization skills were as impeccable as mine.

# THORNS FROM THORNHILL

(What would you expect?)

Participants at the Thornhill Regional had the pleasure of competing against many of the local regulars and several experts from the USA. Eiji Kujirai outdueled everyone else by winning three events. There are always plenty of interesting, crucial boards to talk about. Here are two from the events I played in.

Deal 1. "YOU HAD TO DO IT PARTNER, DIDN'T YOU?"

This was dummy's announcement as she tabled her hand. As it turned out, declarer had recognized a pigeon when she saw one. Me.

After passing with three quick tricks, I was happy to hear partner's double,

but my happiness disappeared quickly. I led the two of diamonds to partner's ace and declarer's king. Partner returned the spade six. Declarer played the spade jack. What is your plan?

Deal 2. WHAT WILL IT BE?

As West, you pick up this hand:

Do you double? After making your bid, you must decide what to lead. What will it be?

Looking at all four hands, you can see that the defence has three tricks outside the trump suit and must score two trump tricks to defeat the contract. They can achieve this with



a spade ruff while blocking declarer's effort to get to dummy for a heart finesse. The key is to win the spade ace at the proper time and lead a third spade for partner to ruff. None of this was easy to see at the table.

To avoid a defensive spade ruff, declarer needs to get to dummy for a heart finesse and thus hold the defence to one trump trick. To foil declarer's intentions, West must duck the first spade, win the second, and give partner a spade ruff. If you duck the first spade and declarer continues with a low spade, you must hop up with the ace to deny declarer an entry to dummy, and then give partner a ruff. This defence deprives declarer of an entry to dummy, and partner takes a second trump trick with the heart king.

Had declarer ducked the first spade, West would have had to win his ace, return a low spade and rely on a club entry to give partner a ruff.

I made the mistake of winning the first spade and trying to cash clubs. Curtains for the defence! Declarer ruffed the second club, travelled to the spade ten in dummy, finessed the heart, and scored up plus 730.

Did I mention that had you defended correctly, you would have won the event?

Deal 2. (See top of next column.)

At the table, West doubled and led the diamond ace. He then shifted to a club. I was able to win the king in

hand, ruff a diamond, and cash the club ace and queen, pitching a spade.

I then took the spade finesse, ruffed a diamond, played a spade to the ace and ruffed the last diamond. This was then the position:

The ten of hearts from dummy now finished West. He won this and could enjoy only two tricks with his king-queen-jack fourth of trumps.

Had West not doubled, I would surely have gone down. In addition, after doubling, had he led a high heart at trick one, I would have gone down one and would no doubt have been muttering about the sins of overbidding!

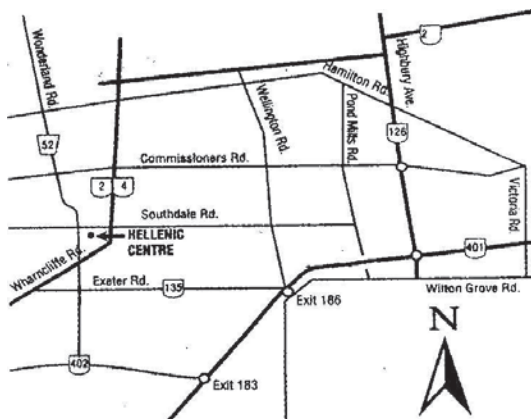

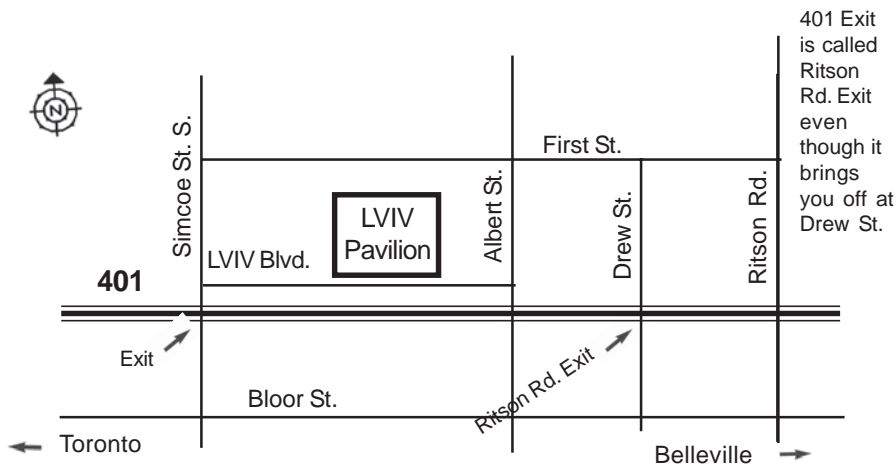
